The Clerk sent the latest SID posts to the Councillor's for information and also informed the Council about a complaint with regards to HGV's on Crewe Road, The Councillor's had in the past managed to get the speed limit reduced from 40 to 30 and get the signage changed so HGV's were directed down the bypass rather than Crewe Road. There had recently been road closures on the bypass so this could have been why there was more HGV's than usual.

Cllr Robinson informed the Council about the Flowerbeds that Rope PC has purchased which can be looked at for future replacements for Wistaston PC.
