58 CHAIRMAN'S REPORT

1. SID post and Speedwatch

Council **AGREED** to the quotation of £100 & Vat (funded from line 23 SID post) for fixing and it was decided that the Clerk will get in touch with the past members of the Speed watch team to see if any are willing to volunteer to start it up again and with past members to arrange the return of the speed guns. It was also agreed that either Cllr Scott or Cllr Perry will attend the installation of the post to learn how the data is downloaded so it can be forward onto Cheshire Police for analysing when most speeding takes place. The Clerk will let them know the installation date when confirmation is received.

Council approved the donation of ± 350.00 to be forwarded to the Royal British Legion (Funded from line 18 – Contribution to Royal British Legion S.137 Payment).

iv. Wistaston Swans WI Green Canopy Tree

Council **APPROVED** the commemorative tree request, and the Clerk will let the WI know to contact the Conservation Group.

v. Community Governance Review Engagement Session run by Chalc

The Clerk informed the Council that Chalc are running a Community Governance Review Engagement session.

vi. Replacement Bench on King Shilling Way (Middlewich Road)

Enclosed in your papers are a couple of Bench options for the replacement Bench.

The Roslin is the same as the one that was installed on Wistaston Green Road in 2019 and is 1800mm in length and base plated with a set of 4 no ground fixing bolts is £743.00 & vat & delivery costs The Eastgate is 1800mm in length and comes with Brown recycled slats and extension legs fixed into

the ground and is £859.00 & vat & delivery costs

The Lowther is slightly larger and is 1903mm in length and comes with Black Vandalex slats and below ground anchor and a memorial plaque measuring 150mm x 40mm for £831.65 & vat with free delivery.

Council **APPROVED** the purchase of the Roslin bench at a cost of £743.00 & Vat and delivery (funded from line 29 Environmental General) The Clerk will no obtain fixing costs.

vii. Wistaston Green Road Bridge & Jubilee Footbridge

Cheshire East Highways are undertaking a scheme for remedial works to the Wistaston Green Road Bridge. They have asked if the Council have any factors they wish to be considered when they draw up their design.

Council **COMMENTED** that the kissing gate on the CE owned side is dangerous as it opens straight onto the road and a pathway either side of the new carriageway needs to be included in the new design.

viii. Civic Service February 2023

Council have **APPROVED** that the Civic Service will go ahead next year (2023) and the purchase of refreshments and the Clerk will get in touch with the relevant organisations to arrange a date and people attending.

ix. Risk Assessment

Cllr Houston commented that the Wistaston Memorial Hall & Community Centre, where the Parish Council own the land, is not identified as a risk.

Council **COMMENTED** that the Memorial Hall arrange their own Risk Assessment, so the Council are not required to do one.

x. Arnold Baker 13th Edition of Local Council Administration

Council **APPROVED** the purchase of the new edition of Local Council Administration at £131.99 (funded from line 15 Administration & Room Hire)

xi. Wistaston Conservation Group Notice Board

Council **COMMENTED** that the location of the board should be on the left-hand side as you go through the gate at Joey the Swan which the Conservation Group has already decided.

xii. Cheshire East Press Release

The Clerk presented a press release to the Council from Cheshire East about new strategies to boost road safety.

xiii. Cheshire East Planning Policy document consultation

Additional Item Not included on the agenda

There has been some building waste fly tipped on land near to the Wistaston Green Car Park at Joey the swan which contains Asbestos. As this needs specialist removal I have gained a quotation from a company used by Cheshire East Council as it needs disposing off quickly which is £402.50 & Vat from Plenty Of Work Ltd (funded from line 29 Environmental General)

Council **APPROVED** the removal of the Asbestos.
